- Collecting emissions data throughout the year to regularly analyse.
- Reduce and eliminate carbon emissions caused by travel by using a digital first approach and working remotely.
- Fostering a culture of sustainability with our organisation by building sustainability awareness amongst our staff, and creating a shared ownership on emission goals.
- Encourage car sharing and public transport where possible.
- Continued with our paperless business systems.
- Continued using sustainable materials purchased for events.
- Continued using local suppliers where possible.

In the future we hope to implement further measures such as:

- Become a carbon neutral organisation by offsetting emissions through certified carbon project schemes.
- Seek and use suppliers who have a commitment to sustainability.
- Continue to monitor and improve our sustainability measures.


This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.
